Contracting Arrangements

- Competitive tender
- Establish Preferred Provider Panels (3 Yrs)
 - ✓ Apprenticeships
 - ✓ Traineeships
 - ✓ Priority Industry Training (PIT)
 - ✓ Participation (Work readiness / Equity
- Contract (1+1+1). Extensions subject to performance and at Corporations discretion
- Panel removal due to no activity



- Contract Management comprising
 - Assigned Case manager
 - Reporting and payment
 - Audit and compliance
 - External stakeholders Intelligence/support

Contracting Arrangements (cont.)

- Once contracted RTOs can:
 - ✓ make application for other panels throughout Contract period.
 - ✓ request monthly variations for places, regions, qualifications, target groups/trade categories.
 - ✓ be invited to participate in, Pre-Apprenticeship, Pre-Traineeship, ASBT and Enterprise training programs where deemed eligible.
- Will be subject to regular performance reviews

Contracting Arrangements (cont.) 2021

- Letters of appointment coming
- Restricted tender for Community Pharmacy for delivery in 2022

2022

- 25 February RTO Forum (proposed)
- May/June go back to market to refresh panels for 2023 - 2025
